### Ontario Provincial Government

Infrastructure Ontario (IO) offers low-cost loans to municipalities and over the years the program has been expanded to cover other non-profit organizations. IO has generally reported a very small positive net interest margin for its lending program, especially in recent years. A positive net interest margin means that the interest IO receives on the loans it has made exceeds the cost of interest IO has paid out.

In 2008, eligibility for low interest loans was expanded to not-for-profit professional arts training institutions, Local Service Boards, and social and affordable housing providers. In 2011, eligibility was expanded to include not-for-profit organizations that own or operate community hubs where both community health and social services are located together. Qualifying organizations:

# **Green Municipal Fund – Sustainable Affordable Housing** (SAH)

Funding for this program is provided by the federal government under the National Housing Strategy. It's \$300 million and offers support to local affordable housing providers – including **municipal**, not-for-profit organizations and housing co-ops – to retrofit existing affordable housing units, or construct energy efficient new builds that emit lower GHG emissions. Funding is provided to help communities achieve:

- Retrofitting existing units or construct new affordable housing
- Generate triple bottom line benefits:
  - Reduce energy and GHG intensity
  - o Increase energy and housing affordability
  - Improve building quality, and increase comfort, health and quality of life for residents

### **Community Housing Transformation Centre**

The Community Housing Transformation Centre (CHTC) is a catalyst for the growth of community housing across Canada. They provide grants, tools and services to support community housing stakeholders (non-profit housing organizations, housing co-ops, federations, associations, groups and **governments**) in their efforts to enact social change, ensure economic sustainability, and bolster growth and efficiency.

### Grants

These grants are available to organizations in all provinces and territories. They are the fruit of a partnership with the CMHC under the National Housing Strategy

### **Sector Transformation Fund**

#### 1. Local Projects

The Local Impact projects stream offers financial support to organizations to support transformative changes aimed at improving organizational resilience and fostering innovative housing solutions. It specifically supports local community housing providers, whether individually or in small clusters.

Projects should introduce new approaches, tools, or methods within the organization or sector that enhance the work currently being undertaken and build organizational capacity among recipients. The projects must offer realistic solutions to identified needs and be aligned with the organization's mission.

### 2. Sectorial Impact Projects

The Sectoral Impact grants support either sectoral service providers, community housing providers or those who are responding to a large identified gap within the community housing sector. It is designed to enhance the service offering at the regional, provincial or national levels. Grants under this category support transformative projects that seek to provide new services to diverse communities in multiple regions, or enhance existing services. The project must provide a viable solution and contribute to strengthening the housing sector as a whole, in a specific region or for a specific type of housing.

The Green Kickstarter Fund is geared toward non-profit housing providers and tenant associations. It aims to create sustainable communities with benefits such as improved health, community well-being, reduced energy costs, and cleaner air and water.

- **Organizational Compass** an online self-assessment tool that allows housing providers to identify strengths and challenges. The Organizational Compass provides guidance in four areas:
  - o Governance
  - o Property management
  - Financial management
  - Social and community relations

  detail the course to follow, step by step, to give the best shot at success. It will also
  serve as a project management tool allowing to monitor and adjust progress.
